An Apostolic Network for Equipping and Releasing Ministers

International Ministries Network (IMN) is an apostolic network for equipping and releasing ministers. IMN is really a threefold network of apostles, ministers, and churches. We are not independent but seek to be affiliated with other similar apostolic networks. National and international networking allows for increased resources and cooperative ministries beyond the capabilities of a small, independent group.

Relationship between ministers and churches is provided through IMN. Our relationships in IMN provide **fellowship**, **support**, **encouragement**, and **accountability**.

Fellowship is provided through newsletters, email, correspondence, ministers' meetings, and conferences held in association with other apostolic networks. **Support** and encouragement is also available through relationship within IMN. For example, IMN can provide advice and counsel in developing your ministry's documents, and financial soundness.

Credentials provided through IMN include Ordination, Minister's License, and Christian Workers License. For a minister who is in training or starting out in ministry, we recommend the Christian Worker's License, which will allow him or her to preach, teach, and minister as the Lord opens the opportunities, including jails, hospitals, etc. Ordained and licensed ministers are authorized to pastor churches, lead ministries, and perform civil ceremonies such as weddings and funerals.

After a person has proved and developed his or her ministry, he or she may advance to License or Ordination. Ordination is reserved for seasoned, experienced, life-long ministers. Credentials may be transferred from other ministerial organizations and denominations.

Spiritual covering is provided through IMN for ministers, churches, and ministry organizations. Prayer, oversight and accountability are needed in the life of every minister. Opportunities for spiritual fathering relationships of mentoring and development are provided through the network of apostles in IMN.

Ministry opportunities are available through networking in IMN. For example, we provide opportunities for coordination and cooperation among ministries for greater resources as well as support and accountability. IMN encourages networking of local, regional, and national ministries.

Through IMN's networking, opportunities to be involved in international ministry are given. These opportunities include participation in international mission trips and leadership conferences. Structure for legal covering of ministries is provided through IMN's duly constituted cooperation with our own constitution and by-laws. This allows IMN to enjoy state, national and international recognition. Also, IMN can provide sample constitutions and by-laws for helping ministries in developing their own legal documents.

Enjoyment should be a part of any effective ministry organization. Friendship, fellowship, and fun are a natural byproduct of cooperative ministry. IMN is a network of real people enjoying life together in ministry.





Benefits of an Apostolic Network:

Listed below are some of the key reasons to be in an Apostolic Network:

Relationship:

- Developing a "kinship of calling" for reaching the city and the world.
- Growing lifelong friendships with a commonality of lifestyle and purpose.
- Having someone to call on in times of need for prayer support and spiritual advice.

Accountability:

- A safe place to share struggles as well as strengthening one another in holiness.
- A network "sounding board" to discuss doctrinal questions and issues that arise in your ministry.

Ministry Support:

• A place to obtain answers and support in all arenas pertaining to life in ministry and the establishing of churches. This includes financial advice in the development of ministries and churches as well as practical guidelines for church planting missions work and community outreach.

Ministry Licensing:

- Providing a legal entity whereby men and women who have demonstrated through their lifestyles and Godly works, a calling to Christian ministry.
